Course Description:			

Management science deals with the presentation and conversion of real-life problems into quantitative models. Through these quantitative models, we can apply mathematical/statistical techniques and attain recommendations about the solution of the problem. In turn, by interpreting these recommendations, we gain insight and guidance about how to overcome that problem. Management science serves as an important consultant for real-life managerial decision making.

Management science has a sophisticated mathematical and statistical background underlying its models and tools. However, having a managerial perspective, we will not dive so much into this theory, but remain highly on the application side. We will define a problem, construct its model and feed it into the computer. Then we will let the computer solve the problem.
