#### **Course Description:**

Any analyst should be able to examine the financial tables and decide about the financial position of these companies. The lecture includes the in debt analysis of the financial statements; balance sheet, income statement and cash flow statement. Furthermore, the students will know the analysis of investing, financing and operating activities.

This is not an introductory accounting course, but an intermediate analysis of financial statements course thus I expect each student who enrolled in BA4818 (BA5818) to have completed a Financial Accounting and Management course (BA 1402 or BA 5401 or their equivalent and BA 2802 or BA5802 or their equivalent). Also, students should have completed basic courses in economics and statistics. Moreover, it is better if they are capable of using a spreadsheet program like EXCEL.

#### **Course Policies:**

**Course Requirements:** The students will be assigned readings from the textbook and are <u>expected</u> to come to class prepared and ready to take part in class discussions.

Attendance is strictly advised in this class. Past experience repeatedly demonstrated that students who regularly attend class and read the chapter assignments perform <u>significantly</u> better than students who have an intermittent attendance and/or who do not keep current in reading the chapters.

**Exams:** There will be **one interim exam and a final** in this lecture. The exams will be closed notes closed book basis.

**Case Discussion:** I will assign each student into groups of 3 or 4 students, the number of group members will be decided for you by the instructor after the registration period. **Each group will prepare a written (word processed) analysis of the case. The details of the case will be presented later during the semester.** At the end of the term each of you will be required to provide an evaluation of the

contribution of each of the group members to the group's output. The case will be due on **November** 27, 2023 during lecture hours.

#### **Course Project and Presentation:**

The course project will be held in groups. You form your own groups of 3 to 4 students and the number of group members will be decided for you by the instructor after the registration period. You are required to choose a company which is listed in Borsa İstanbul to examine and obtain its financial statements. **You must register your choice with the lecturer and obtain the approval.** At the end of the semester you will have to present and discuss your main findings. You can use visual aids in your presentation. In addition, at the end of the term each of you will be required to provide an evaluation of the contribution of each of the group members to the group's output. The project presentations will be at the last week of classes. **The project report will be due on January 10, 2024 by 12:00 p.m.** 

Quizzes: There will be unannounced quizzes during some classes. You will be asked one or two questions about the material covered in that lecture or the previous lectures. There won't be any make-up quizzes.

**Discussions:** There will also be pre-assigned readings which will be discussed during the lecture. Please read them carefully and **attend the discussions**. **I also ask you to prepare a written document not longer than 1 or 2 pages related to the discussions**.

**Reading Assignments:** The following pages give the schedule for the reading assignments. The lectures will stress the most important and/or most difficult material.

**Presentation Slides:** A copy of the presentation slides is available at the course web page. These slides can be used as chapter summaries and utilized while taking down notes during class.
