Course Description:	
<p>This course aims to analyze how financial markets and financial institutions; financial systems as a whole, affect the macro economy. We discuss the risks to the macro economy due to the structure of financial systems. Moreover, the financial structure of the countries will be examined throughout the course. The course intends to focus on the empirics of the subjects that will be argued, with special emphasis on the different country examples.</p>

Course Policies:

Students who sign up for this course should have completed BA2802 Principles of Finance course (or equivalent), and should have an understanding of algebra and statistics. Students are required to actively participate during the lecture hours. Each student is expected to be prepared for the required readings. Assigned readings will be presented by students, and there will be class discussions after presentations. Students are not expected to discuss the details of econometrics of the assigned articles during the presentations.

There will be two written midterm examinations. There will be no final examination in this course. A re-sit exam will not be given. No “extra” work above the aforementioned will be accepted or credited.
